FREQUENTLY ASKED QUESTIONS (Information with effect from AUGUST 2017)

1. Who are eligible to apply for the MSc (Project Management) Concurrent Degree Programme?
NUS undergraduate students (year 2, year 3 and year 4 semester 1) who have completed 80 Modular Credits with a CAP of at least 4.0 are eligible to apply for the CDP Programme.

3. When is the application period?
The August intake application period is from 26 December to 15 January
The January intake application period is from 15 July to 15 August
 4. If a student sponsored in his/her studies, does a student need to get a written approval from the sponsor company to pursue the CDP Programme?
Yes, a student on scholarship is required to get a written approval from the sponsor company.

5. Does a student with Tuition Grant for the BSc (PFM) degree need to get a written approval from MOE to pursue the CDP Programme?
Singaporeans with a Tuition Grant from MOE and not bonded do not need to get a written approval from MOE.
6. Is there any session conducted for this Programme.
Yes, the Department conducts the briefing sessions as follows:
August Intake briefing session is sometime in January
January Intake briefing session is sometime in August
7. How do we know the status of our application?
Students will be inform via email on the application status and hardcopy of the letter will send by post
 - (a) August Intake application status will be known from March onwards
 - (b) January Intake application status will be known from October onwards
8. Can a CDP student do part-time masters in PM?
No, CDP student has to be on a full-time basis.
9. How many modules does a CDP student need to take

CDP Student **must take**:
 - 2 MSc (PM) modules during the undergrad years if he/she is **not** specializing in Project Finance
 - 3 MSc (PM) modules during the undergrad years if he/she is specializing in Project Finance
 - 5 MSc (PM) modules during the additional semester after the final undergraduate semester whether specializing or not specialising

10. Does a student need to take UE modules in the CDP?
CDP students do not need to take UE modules as these UE modules will be double counted from Level 4 undergraduate modules.
11. Will the PM modules taken during completion of bachelor's degree counted towards the bachelor's degree CAP?
No, PM modules taken during the undergraduate will not be counted towards the bachelor's degree CAP.
12. Is there any double count modules for BSc (Civil Engineering)? I have to finish 3 Technical Elective for my Civil
As a CDP student, you may double-count any Level 4 undergraduate modules in the BSc (Civil Engineering) as shown in the CDP Program structure.
13. By when the CDP students required to complete the UG requirement?
CDP Students are expected to complete the UG requirement within 7 or 8 semesters

14. Does a CDP student need to file for graduation?
CDP Students do not have to file for graduation.
15. Does a CDP student get official transcript for completion of BSc.(PFM) or other Bachelor's degree programme?
Does the transcript shows the degree classification or it shows "pass/proceed?"
Yes, a CDP student gets conferment for BSc (PFM) or other Bachelor's degree. The official transcription will show the degree classification.
16. Does the specialisation status print on the degree or transcript as an official proof?
The Project Finance specialisation description will only reflect in the NUS transcript after the degree conferment process has completed The specialization status description will not be reflected in the MSc (Project Management) degree scroll.
17. Can a CDP student use the MSc modules to take UE for his/her undergraduate?
No, you are not able to use the MSc modules as UEs for your undergraduate.
18. How should we MAP the modules to UEs?
The MAPPING of the modules will be handled by the Department.
19. UE is consider as SU or the grades brought forward for Master's CAP?
UE modules from Level 4 undergraduate will not be counted for the Master's CAP. It is not an SU. It exempts you from taking 2 or 3 MSc (PM) modules.
20. How can I withdraw from the CDP Programme?
You may download the "withdrawal" form and submit to the hosting Department for processing.
